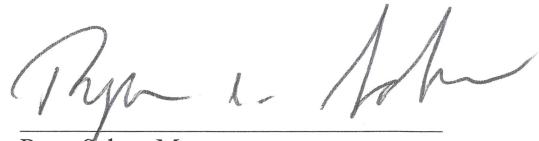

Open Forum Response to Sally Balogi, Driveway and Dayton Road Concerns

The City Engineer stated that at the July 28, 2025, Open Forum, Sally Balogi of 501 West River Parkway addressed the Council with several concerns related to her property and the surrounding area, specifically her driveway condition and traffic on Dayton Road. Because Champlin did not have a driveway permit prior to 2023, improvements to individual driveways are not clearly recorded in City files. The files staff reviewed indicate the lot was platted in 1952, and the home was built under a 1959 permit. In 1983, the City completed a project installing the street, sewer, and water utilities, with assessments applied to parcels for the work. Assessment records show a charge for driveway and boulevard restoration, with an optional "extra" charge for driveway work. Records indicate the homeowner at the time was assessed the standard driveway and boulevard restoration and did not pay for the "extra", so it is assumed that restoration included bituminous in the right-of-way, as what is seen onsite today. Based on available records, the existing bituminous driveway appears to date back to 1983, making it 42 years old. For reference, new construction work is typically covered under a two-year warranty after final payment, well beyond the timeframe for this driveway. Hennepin County is currently conducting a corridor study for Dayton Road. Concept plans for this area include reconstruction of the roadway and installation of pedestrian facilities on both sides of the road. Design for this work will begin this fall, with an anticipated construction in 2028.

ADVERTISEMENT FOR BIDS FOR THE WATER TREATMENT PLANT NO. 1 FILTER
BAY REHAB, IMPROVEMENT PROJECT NO. 22509**

WHEREAS, plans and specifications have been submitted for the Water Treatment Plant No. 1 Filter Bay Rehabilitation Project, Improvement Project No. 22509 and

WHEREAS, the project area consists of replacement and installation of anthracite and silica sand filter media, filter influent valves, filter effluent valve operating rods, blasting and recoating of concrete filter tanks and influent weirs, and replacement and installation of filter backwash nozzles, as needed.

NOW, THEREFORE, BE IT RESOLVED by the Champlin City Council that:

1. The plans and specifications for the above-mentioned area are hereby approved.
2. The City Clerk shall prepare and cause to be placed on the City website and in Quest Construction Bulletin, an advertisement for bids upon the making of such improvement under such approved plans and specifications. The advertisement shall specify the work to be done and shall state the bids will be received by the Clerk until 10:00 a.m on September 11, 2025, at which time they will be opened electronically. Any bidder whose responsibility is questioned during consideration of the bid will be given an opportunity to address the Council on the issue of responsibility. No bids will be considered unless sealed and filed as set forth in the instructions to bidders in compliance unless with requirements of electronic bidding and accompanied by a cash deposit, cashier's check, bid bond, or certified check payable to the Clerk for 5% (five percent) of the amount of such bid.
