Overview of Worksession Discussion

Approve Amendments to the Sick Leave Policy Motion

Motion by Councilmember Moe and seconded by Councilmember LaCroix to approve the proposed amendments to the Sick Leave Policy to ensure compliance with the upcoming MNPL law, recent legislative changes to the ESST law, and to incorporate best practices. Voting in favor were Mayor Sabas, Councilmembers Moe and LaCroix. Voting against: none. Motion carried.

Approve Compensation Study Proposal from Abdo Solutions Motion

Motion by Councilmember Moe and seconded by Councilmember LaCroix to approve of Abdo Solutions' compensation study proposal. Voting in favor were Mayor Sabas, Councilmembers Moe and LaCroix. Voting against: none. Motion carried.

Renew the Joint Powers Agreement (JPA) with the State of Minnesota for Membership in the Human Trafficking Investigators Task Force (MNHITF) Motion

Amendment to Data Storage Server Sharing and Governance Agreement Motion

Motion by Councilmember Moe and seconded by Councilmember LaCroix to accept admittance of the Hennepin County Sheriff's Office into the Agreement for data storage. Voting in favor were Mayor Sabas, Councilmembers Moe and LaCroix. Voting against: none. Motion carried.

Approve Generator Replacement Quote for Public Safety Motion

Motion by Councilmember Moe and seconded by Councilmember LaCroix to approve the purchase of a new 230KW generator for the Public Safety/City Hall building at a cost of \$236,457 to be ordered in 2025 and delivered and paid for in 2026. Voting in favor were Mayor Sabas, Councilmembers Moe and LaCroix. Voting against: none. Motion carried.

Approve Generator Replacement Quote for Public Works Motion

Motion by Councilmember Moe and seconded by Councilmember LaCroix to approve the purchase of a new 100KW generator for Public Works at a cost of \$230,465 to be ordered in 2025 and delivered and paid for in 2026. **New Business**

City Planner Smith stated that in 2022, the City of Champlin acquired the property at 12650 Elm Creek Crossing as part of the City's goal to establish a greenway along the Elm Creek Corridor. The acquisition was funded through the Outdoor Heritage Conservation Partners Legacy Grant Program. A small portion of the property, approximately 4,653.6 square feet, lies west of Elm Creek Crossing, separated from the main parcel by the roadway. All other property along the Elm Creek Corridor on the west side of the roadway is owned by Three Rivers Park District (TRPD). TRPD has requested that this portion of land be transferred to their ownership. To facilitate this transfer, a lot split is required to divide the land.

Maggie Heurung, TRPD, explained that this land transfer would provide a clear boundary and make it easier for the City and TRPD to maintain their land. She commented that the land would remain as open space as it has in the past.

The City Planner advised of a recent land acquisition that TRPD obtained in 2024 and noted that this sliver of land would make all the land on the west side of Elm Creek Crossing under TRPD ownership.

Councilmember Moe noted a structure that was on the property when it was acquired in 2024 and asked if TRPD would be removing that structure.

Ms. Heurung replied that the home has already been moved and is listed for sale through the company that moved the home.

Councilmember LaCroix commented that this would make sense and is another step as they continue to preserve the Elm Creek watershed through the area.

Mayor Sabas expressed thanks to the TRPD for the work it does in Champlin and the surrounding communities.

Resolution 2025-60

Councilmember Moe introduced the following resolution and moved its adoption:

Finance Director Johnson stated that the City has historically offered a “garbage hold” or “snowbird” service to qualifying properties, which suspended solid waste fees for a minimum of four weeks. She explained that this is not allowed by Hennepin County or the garbage hauler, and therefore, a change is necessary to the ordinance.

Mayor Sabas commented that this gives him pause, as this was previously offered to residents, but recognized that they learned that even though the City was pausing, the cost was then being passed to the other residents. He recognized that it is out of the control of the City, as the County and hauler do not allow this.

Councilmember Moe asked if a resident could cancel their service if they would not be at their property for six months.

Finance Director Johnson replied that would not be an option.

City Administrator Max stated that if the property has been deemed uninhabitable by the City, there would be an exception for that.

Councilmember LaCroix recognized that organics and recycling are outside of the control of the City, but perhaps when they negotiate the next trash hauler, they could discuss this topic.

Finance Director Johnson confirmed that the contract was just negotiated through 2029, but noted that she would include that in future discussions.

Ordinance No. 920

Councilmember LaCroix introduced the following ordinance, waiving the first reading, conducting the second reading, and moving its adoption:

Ordinance No. 921

City Administrator Max stated that on October 27<sup>th</sup>, the City Council accepted the resignation of Councilmember Nate Truesdell, declared a vacancy on the City Council, and established a date for a Special Election to fill the remaining term of Councilmember Truesdell's seat. The City is currently in the process of filling the vacancy by appointment, with interviews scheduled for November 17<sup>th</sup>. The appointment will run until May 12, 2026, when a special election will then take place in Ward 3. The special election will be held to fill the remaining term from May 2026 – December 31, 2028. When a Special Election is called to be held at a time other than the General Election, an ordinance must be passed by the City Council to establish the Special Election date.

Mayor Sabas commented that the Council will follow an appointment process to fill the vacant seat. Interviews will be held next week in anticipation of having the person join the Council at the first meeting in December. He noted that the person would serve until the special election, and following the election, the person elected would join the Council. He explained that this appointment and special election process were necessary because of the amount of time remaining in the term.

Councilmember Moe introduced the following interim ordinance, waiving the first reading, conducting the second reading, and moving its adoption:

An Interim Ordinance Providing for Special Elections to Fill Certain Vacancies in Elected Offices at  
Times Other Than the Regular City General Election

The motion for the adoption of the interim ordinance was duly seconded by Councilmember LaCroix, and upon vote being taken thereon, the following voted in favor thereof: Mayor Sabas, Councilmembers Moe and LaCroix, and the following voted against the same: none, whereupon said interim ordinance was passed this 10<sup>th</sup> day of November 2025.

**WHEREAS**, Three Rivers Park District requested a lot split to divide and convey a 4,653.6 square foot portion of the property at 12650 Elm Creek Crossing; and

**WHEREAS**, the lot split creates two parcels of record, legally described as follows (see attached survey):

**PARCEL A (CITY OF CHAMPLIN)**

**ORDINANCE AMENDNG CHAPTER 46 SOLID WASTE**

**Sec. 46-15. Definitions.**

...  
*GarbageRefuse hold* means a temporary suspension of all solid waste ~~refuse~~ services for an extended period of time, ~~at minimum four consecutive weeks.~~

**Sec. 46-21. Placement of litter in receptacles.**

(a) Persons placing litter in public receptacles or in authorized private receptacles shall do so in such a manner as to prevent it from getting out of the receptacle by reason of the elements.

Single-family through four-dwelling unit property owners/renters shall be required to use ~~refuse and recycling~~ collection containers provided for the disposal and collection of all refuse, recyclables, organic recyclables, and litter, and garbage.

Property owners/renters in complexes greater than four dwelling units shall be required to place their refuse, recyclables, organic recyclables, and litter in a collection container substantially similar to the collection containers used for single-family through four-unit properties. A collection container shall be required for recyclables; however, they may use a one sort containers or two sort containers for recyclables.

Oversized items and extra pick-up orders may be set out next to the regular refuse and recycling collection container on a periodic basis as needed and only for a period of not more than 24 hours before the scheduled pick-up.

**Sec. 46-49. Generally.**

Every property shall in a sanitary manner, separate and dispose of solid waste that may accumulate upon the owner or occupants' property by entering into an agreement with a hauler or by arranging service through a city contract to provide

~~refuse and recycling~~ collection service in accordance with Minn. Stats. § 115A.941 - Solid Waste Required Collection, Chapter 443 - Rubbish Removal, and Hennepin County Ordinance 13.

Sec. 46-51. Generally.

(h) *Solid waste service rates.*

(3) Each residential customer will be charged a solid waste service charge regardless of whether they utilize the service. ~~Customers who apply for a hold and are approved by the city, shall receive a temporary suspension of all solid waste services and charges for a minimum of 30 days. Customers shall receive a refuse hold if all of the following conditions are met:~~

- a. Property is deemed uninhabitable by the City.
- b. Minimum of three month suspension of service.
- c. Approved by the City.

AN INTERIM ORDINANCE PROVIDING FOR SPECIAL ELECTIONS TO FILL CERTAIN VACANCIES IN ELECTED OFFICES AT TIMES OTHER THAN THE REGULAR CITY GENERAL ELECTION

**The City Council of Champlin, Minnesota ordains:**

**CHAPTER 2 – ADMINISTRATION; ARTICLE II – CITY COUNCIL; SECTION 2-23 – DATE OF ELECTION:**

**SUBSECTION 1. DEFINITIONS**

For the purposes of this ordinance, the following terms shall have the following meanings:

City. The City of Champlin, County of Hennepin, State of Minnesota.

General Election. A “general election” is an election held at regular intervals on a day determined by law or charter at which the voters of the state or any of its subdivisions choose by ballot public officials or presidential electors.

Special Election. A “special election” is an election held at any time to fill vacancies in public offices.

Vacancy. A vacancy occurs for the reasons stated in Minnesota Statute Section 351.02 or other state law.

**SUBSECTION 2. APPOINTMENT TO VACANCY**

Pursuant to Minnesota Statute § 412.02, subd. 2a, a person shall be appointed to fill the vacancy until the special election is held and the winner of the special election is qualified to take office.

**SUBSECTION 3. SPECIAL ELECTION TIMING**

If a vacancy occurs and a special election to fill the unexpired term is required pursuant to Minnesota Statute Section 412.02, subd. 2a, and the City Council determines it is in the best interest of the city to conduct a special election at a time other than the next

regular city election, then the special election must be held on one of the uniform election dates pursuant to Minn. Stat. 205.10, subd. 3a. The City Council has determined that a special election shall be held on May 12, 2026 to fill the unexpired term of Ward 3 Councilmember Nate Truesdell.

**SUBSECTION 4. SEVERABILITY**

If any provision of this ordinance is found to be invalid for any reason by a court of competent jurisdiction, the validity of the remaining provisions shall not be affected.

**SUBSECTION 5. EFFECTIVE DATE**

This ordinance becomes effective upon passage and publication and will expire on December 31, 2026.
